Be sure all parts & pieces are present before you tag items. This includes working batteries.

COMPLIANT

Important Safety Guidelines apply to car seats, cribs, infant equipment & toys. Go to <u>cpsc.gov</u> to check for recalls!







REQUIRED FORMS

- <u>Crib Checklist</u> (We accept cribs manufactured after June 2011)
- Car Seat Waiver (Must include printed OR digital owner's manual)

DO NOT BRING Women's or men's brand clothing or shoes







Just because you wore it when you were pregnant, doesn't mean it will be accepted!

Maternity clothing must be maternity brands

The maternity category includes post partum and nursing apparel and accessories



DO NOT BRING oversized women's or men's clothing to sell as maternity



ITEMS WE DO NOT ACCEPT

The following items are not accepted at JBF Prince William

X used nipples X used pacifiers X used teethers X NEW or used jewelry teethers X smart body monitors *(Owlets versions 1-3 cannot be sold WITH the box)*

X formula samples/medicine X formula samples/medicine X open bottles of shampoo/lotions etc X Otteroos X Anti-rebound car seat attachments

X used underwear, boxers

X twin+ size mattress X ALL crib rail protectors and crib bumpers (including mesh bumpers) X infant sleep wedges/positioners X baby bottles with old/used nipples X booster seats without straps X used mesh food feeders & teethers X baby food or formula X Slumber pods or pack n play tents X pack n play after market mattresses

Items that DO NOT follow the CPSC safe sleep guidelines such as:

X Baby Boxes X Doc-a-tots X infant tents X sleep wedges X in-bed sleepers X baby nests & pods X compact & travel bassinets X inclined sleepers.

X yearly/dated books and outdated books X Moonlite story projectors X used play-doh X water beads X generic stuffed animals X magnetic balls X books for adults X gardening & self help books X magazines for adults X outdated parent/pregnancy books (> 5 yrs) X reference books (> 2 yrs) X books with ripped spines/pages X rated R, M or adult DVDs X cassette/VHS tapes X PC games X TV gaming consoles (handheld ok) X video games rated MA or higher X all home-made items



Kids Grow Fast!

Each child cycles through a wardrobe every 6 months. So, if you're feeling like you have lots of outgrown clothes in your home, you're not alone!

Plus, you can also sell items you likely have around your home. Here are some places to look for more to sell.

Check all over your home!

Keep | Toss | Sell

It's okay to **KEEP** the items that you just aren't ready to part with yet. **TOSS** the items that are too well-loved (stains, missing pieces, or are not working).

STEP 3 PREP

Maximize Profits

- Bundle Completed Sets
- Choose to Reduce!
- The better they look, the better they sell
- Iron wrinkles, button buttons, and snap snaps | sizes MUST be the same



Gather these supplies to make your prep faster:

- hangers
 clear self-sealing bags (zip-loc)
 ribbon/string
- zip-ties
- clear tape & painter's tape • scissors • safety pins or tagging gun
- clear (saran) wrap
- hole-punch

TOYS & GEAR

Two Essentials:

- Tag is attached securely (won't fall off)
- All pieces secured together (won't separate; tape bags closed)





STEP 3 PREP

CLOTHING



Hanging & Tagging Clothing

Put all clothing on a hanger. Attach JBF tag to clothing with safety pin or tagging gun. If using a tagging guns, only go through a seam. Bundle socks, infant mittens & hats, as well as other small accessories in clear self-sealing bags. Attach JBF tag to the bag with clear tape.

Hangers

Be sure the hanger hook opens to the left, like a "?" Attach JBF tag to front of item. Hangers may be plastic or wire, but clothing size 5 and under must be on child size hangers.



Hanging pants

Pin pants to the top rail of the hanger. If it is a set, hang shirt on the hanger, turn the hanger around, and pin the pants facing front-out on the hanger rail under the shirt. The closer the pins are to the center of the hanger, the less likely they are to slide off during the sale.





Creating Outfits

It's a great idea to create sets in sizes NB-5/6. Larger sized items sell best as individual pieces since older children tend to be more picky about what they wear. All items MUST be the same size.





Tagging Gun

If you use a tagging gun to attach JBF tags, only puncture the garment tag or an inside seam at the collar. (not the armpit) so that you do not damage the fabric. If you puncture the fabric, items will be rejected.

Safety Pins: Avoid pinning one item to another (pin to the hanger) - it will not be accepted. Instead, hang one item and then pin second item to the top rail of the hanger or pants pinned to hanger rail underneath the shirt.

Hanging Multiple Items on a Hanger

Multiple items can be hung on a single hanger. Use a safety pin through the waistline to attach pants/skirts to hangers.

Items MUST BE the same size.

example: 12 mo and 12mo **not** 12mo and 12-18m

Cloth Items

Do not bundle cloth items in Bags - shoppers want to see the quality/condition of what they are buying. Instead, hang items.

STEP 3 PREP

Blankets/towels, etc. should be on a hanger - they will sell better.

Accessories

Use clear bags to bundle sets of socks, hair accessories, infant mittens and hats.

Display neatly so shopper can see well. Tape tags to the outside of the bag with clear tape.

Hats

Simply attach JBF tag to hats using a safety pin or tagging gun. No need to use a bag.





TIPS & TRICKS

When creating a set, ONLY use safety pins to attach the pieces together on the hanger rail. If you are using two hangers, tape or zip tie the hangers together. Do not use twine or rubber bands.



Backpacks, lunch boxes, diaper bags, baby carriers should be placed on a hanger and zip-tied to the hanger.



You can bag "like" items together to save time. And use saran wrap to display puzzles.



For drop off- keep sizes separate by alternating sides for each size or put them in bags.

We recommend pricing at 1/3 of retail!

Shopper-focused pricing - Ask yourself, "What price would make me buy this item without hesitation...and brag about my bargain to my friends?"


• You MUST select the appropriate CATEGORY. All tags must have a category.

- Be as DESCRIPTIVE as possible in case the tag falls off (so we can match it back up)!
- Add your price
- Check the REDUCE box if you would like your items reduced on discount days. (50% off)
- Check the DONATE box if you would like unsold items donated after the sale.

CAUTION: Unsold items marked for donate will be gathered for the charity when the sale ends on Sunday afternoon and cannot be retrieved by the consignor.



TIP! Talk-to-Text

If you are entering tags on your mobile device, use talk-to-text to go even faster.





Print Your Tags

Print tags on 8.5"x11" white cardstock. Tags print 9 per page.

Be sure to replace ink as needed, faded tags will not scan.



CREATE TAGS

You did it!

Now that your items are tagged, you'll want to pack items **organized by type and size** so that your Drop Off Appointment is easy and fast.



Plan for 60-minutes to drop off your items. Longer if you have 300+ items to drop off. Be prompt for your drop off appointment, but **DO NOT** come early. You will receive your presale passes when you drop off.



Take your clothing items to be inspected. After they are inspected, you will hang them in the appropriate size. You may put your non-clothing items on the sales floor while you are waiting for your clothing/shoes to be inspected. Clothing will be hung by gender/size & type (pants on top rail | shirts on bottom rail) behind the rounder with your CONSIGNOR LETTER. For example, L-123-ABC, "L" is your consignor letter.

Before you leave, you will claim rejected items, Please read all sale week emails for more specific instructions on drop off/pick up.

Pick up is self sort of your own items on Sunday, Sep 8th, by appointment only. **Don't forget your appointment time!**

Unclaimed items are donated at 8:30 pm!

If you are donating all items you DO NOT need to come to pick up. The Charity Partner comes to the venue to pick up all donated items for families in need.
